Matching Gifts

Does your company match gifts?

Many employers sponsor matching gift programs and will match any charitable contributions made by their employees. That means that if you make a gift of \$50 today, and your company matches gifts, Ruth's House will receive \$100!

If your company is eligible, follow the steps to request a matching gift form from your employer (sometimes these can be completed online), and send it completed and signed with your gift. If you don't see your company listed, contact your HR department to see if your gift is eligible for a match.
